During the 2020-2021 school year there were a myriad of efforts and opportunities made by Leonardo da Vinci Health Sciences Charter School to consult community members. Leonardo da Vinci Health Sciences Charter School gathered feedback to inform the development of the Local Control Accountability Plan (LCAP), the Expanded Learning Opportunities Grant Plan (ELOG) and the Learning Continuity and Attendance Plan (LCP). Feedback from the LCAP, ELOG, and LCP was used to formulate this ESSER III expenditure plan. Stakeholders included in community engagement opportunities included: Board of Trustees, administrators, teachers, support staff, governance committees, English Learner Advisory Committee (ELAC), parents/guardians (including parents/guardians of students with disabilities), and students (including students experiencing homelessness, students in foster care, and military-dependent students).

All non-student stakeholders at Leonardo da Vinci Health Sciences Charter School were invited to participate and comment in public Board Meetings, Governance Committees, and ELAC. Additional and meaningful feedback was gathered from the school community with the use of Google Forms surveys to identify community needs on the LCAP, ELOG, and LCP. Leonardo da Vinci Health Sciences Charter School will ask for additional input from the Audit & Budget Governance Committee in the first week of October and will include on the upcoming regularly scheduled Board Meeting agenda the approval for the ESSER III plan and the opportunity for public comment. Prior to this meeting, the ESSER III plan will be emailed to the community and posted on the Leonardo da Vinci Health Sciences Charter School’s website for parents/guardians and staff to provide feedback using a Google form.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.
